We are seeking talented designers and animation experts to produce and deliver a number of animated videos, adverts, motion graphic as per the instructions of the ECR Party Secretariat.

This activity aims to support, develop and grow the ECR Party and its engagement with European Citizens in forming European political awareness and in reflecting and expressing the will of citizens of the Union, by providing a number of visual products that inform European citizens about positions and activities of the ECR Party.

Description of the services under this tender

The tender comprises of the following services:

- Produce and deliver "Explainer Videos" (animated) "adverts" (animated) "GIFS", "Motion Graphics" and other visual material as requested
- Provision of consultancy services in the form of regular interactions, discussions and direct consultations with ECR Party staff;
- Participating in regular meetings in Brussels, and when not possible through virtual means;
- Any other related services needed to the final product
